This is your Regular Investment Plan Agreement with RBC ISAN Administrator for Antipodes Partners Investment Funds (User ID 499423). It explains what your obligations are when undertaking a Direct Debit arrangement with us. It also details what our obligations are to you as your Direct Debit provider.
