

# Privacy Statement

Antipodes Partners Limited (**Antipodes**) understands and appreciates that you, as an Antipodes website visitor, are concerned about the confidentiality and security of information Antipodes may collect about you. Antipodes is committed to providing you with information on our services within a secure and confidential on-line environment.

By accessing this website you consent to the processing by us and our agents and service providers of any personal data provided by you when you use our website.

Our privacy statement sets out, for your information:

## **What information we collect from you**

The types of personal data that we collect from you generally include your name, contact details such as your email address and telephone number and location.

We will not collect any information that identifies you as an individual unless you knowingly provide it to us.

Any personal information you supply will be used only in accordance with this Privacy Statement.

If you browse on the website, read or download information, our system will record the date and time of your visit and the pages viewed and information downloaded.

## **Use and disclosure of information**

Any information we collect from you, may be used by any entity carrying out functions on behalf of Antipodes for the purpose of:

1. enabling Antipodes to provide services;
2. providing information to you in accordance with your requests;
3. the purposes of enabling Antipodes to undertake research, planning, product development, risk assessment, risk modelling and marketing;
4. such other purposes as individuals would reasonably expect their personal information to be used for; and
5. any other purpose required by or to the extent permitted by law.

We will only disclose personal information to third party entities, whether in Australia or any overseas jurisdiction, carrying out functions on behalf of Antipodes on a confidential basis. You should note that information we collect from you may also be disclosed to third parties if that disclosure is required by or to the extent permitted by law.

### **Security of your information**

Antipodes takes reasonable steps to preserve the security of personal information it collects. Antipodes cannot ensure or warrant the security of any information you transmit to us or receive from our online products or services and you do so at your own risk. Once we receive your transmission, we take reasonable steps to preserve the security of information on our own system. From time to time the website may contain links to other websites, and Antipodes is not responsible for the privacy practices or the content of these websites.

### **Cookies**

A cookie is a small data file placed on your computer by Antipodes' server. A cookie contains information about your visit to the website.
