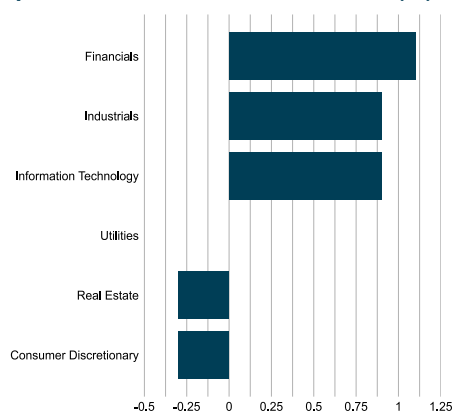

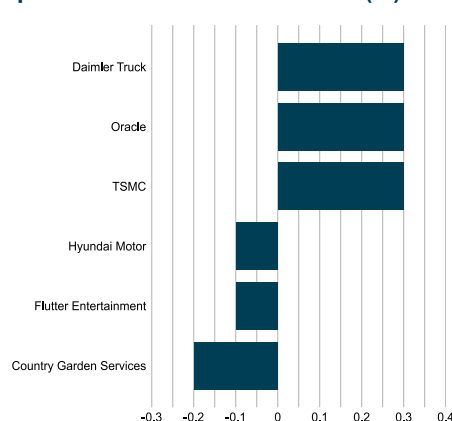

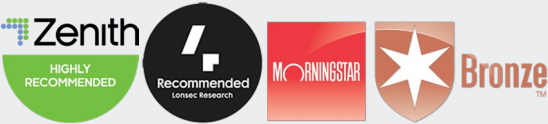

Fund features

- Objective to achieve absolute returns in excess of the benchmark over the investment cycle (typically 3-5 years)

  - Currency exposure of the underlying stock position (net short currency position not permitted)
